



## Therapy/ Service/ ESA Dog Training Contract

\_\_\_\_\_, Client hires by contract Wing & Shot LLC for the purpose of dog training. \_\_\_\_\_, dog(s), which will be trained by Wing & Shot LLC. Bound with this contract.

(A) TRAINING FEE: Wing & Shot LLC. Will be paid the training fee of \$\_\_\_\_\_ for each dog listed above. Payment is due in full upon drop off of the dog(s). The training period listed above is 12- 14 months. If training exceeds 14 months a new contract will be renegotiated at that time.

In return for payment Wing & Shot LLC. will train dog(s) listed above.

(B) FEED: Expense of feeding dog(s) is included in the training contract price. Wing & Shot LLC. feeds Purina Pro Plan dog food.

(C) VETERINARY CARE: Wing & Shot LLC. will on a routine basis, inspect dog(s) for injury or sickness. Proper veterinary care will be sought in the case that it is deemed necessary by Wing & Shot LLC.

The client authorizes needed veterinary care by signing this contract. Client also agrees to reimburse all medical service and medicine fees. Payment of these fees will be billed to the client accordingly.

(D) VACCINATIONS: Wing & Shot LLC. will be responsible for maintaining dog(s) vaccinations during the 12- 14 month training period that the dog(s) is in our care. The

client will then be responsible to reimburse any and all veterinary payments and will be billed accordingly.

**(E) Transportation:** During the time the dog(s) is in the custody of Wing & Shot LLC. has permission to transport training dog(s) to a variety of locations such as schools, retail stores, airports, restaurants, etc. for training purposes.

**(F) DEFAULT:** In the event client fails to pay fees and/or expenses outlined by this document for a period of 90 days, ownership of contracted dog(s) will be forfeited. After notification that the contract has reached the 90-day delinquent status, client will forfeit contracted dog(s) to cover outstanding balance due to Wing & Shot LLC. Also, client will be obligated by this contract to transfer all ownership documentation and registration to Wing & Shot LLC. If legal action is required to obtain proper ownership documentation, client will be bound by this contract to pay attorney's fees and court costs incurred by Wing & Shot LLC. to obtain ownership transfer.

**(G) HOLD HARMLESS:** The client will hold Wing & Shot LLC. free and harmless from any and all claims, liability, damage, loss or expenses arising out of any injury to any person or to any person's property by the dog(s) named in this contract, while in the care, custody and control of Wing & Shot LLC.

**(H) LIABILITY LIMITATION:** The client acknowledges that it is accepted that the dog training will not provide exact results. Each dog is different regarding ability, intelligence and temperament. Wing & Shot LLC. makes no expressed, nor implied guarantee, to the results reached in training or to the level of competency reached by contracted dog(s). Wing & Shot LLC. reserves the right to terminate this training contract at any time, and to request that the client pick up his/ her dog(s). All pre-paid training fees will be refunded on a daily pro-rated basis if Wing & Shot LLC. would make said request.

The client accepts that this is a training contract and that Wing & Shot LLC. is not an insurer of the condition of the dog(s) while it is in the custody of Wing & Shot LLC.

Wing & Shot LLC. is in no way responsible for the cost of replacing contracted dog(s) or for any damages of any kind, should contracted dog(s) die, be stolen, escape, or become injured, or become ill while in the care of Wing & Shot LLC. Proper care will be given, and generally accepted training methods will be followed while dog(s) is under contract. Training can be dangerous, and injury or death can occur, even when careful measures have been taken.

All liability is removed from Wing & Shot LLC. at the end of the training period and the dog(s) is back in the custody of the client.

(I) SOLE AGREEMENT: This contract is the sole agreement between the client listed and Wing & Shot LLC. Any prior agreements, promises, negotiations, or representations not expressed in this contract are no longer in force or effect. Exception being additional terms agreed upon as listed below.
